They are advised to come along with their **original documents**, i.e. (i) Matriculation certificate as proof of age, (ii) Course completed Act Apprentice/ITI pass certificate in the relevant trade issued by NCVT or SCVT, (iii) SC/ST/OBC certificate if applicable in prescribed proforma, (iv) No objection certificate from the present employer if employed in Central/State Govt. or Govt. undertakings, (v) Lower portion of the call letter of the written examination, (vi) Original call letter sent to the candidates for document verification, (vii) Two recent colour passport size photographs (not to be attested). Candidate should also bring one set of Photostat copies of all above-mentioned certificates duly attested by a Gazetted officer with name and official stamp. However, if any of the above-mentioned candidate does not receive the call letter due to any reason, he/she should report to the office as per the schedule indicated above.

It may be noted that merely calling a candidate for document verification does not in any way entitle him/her to an appointment in the Railways. The candidature of all the above-mentioned candidates are purely provisional and subject to their fulfilling the eligibility criteria in all respects and having Act Apprenticeship/ITI certificate in the relevant trade.
